TERMS AND CONDITIONS

1. All applications must be made **only** through regular postal mail, and **must** reach the Office of Studies **at least two months** prior to the commencement of the course applied for. No application will be accepted later than this due date. *For example, if you are applying for the February 2003 course that begins on February 10, 2003, the application must reach the office by December 10, 2002.*
2. The application must be made along with the registration for the course. The application form may be requested from the office or downloaded from our website www.kym.org. In this case you don't have to pay the registration deposit, but you will have to pay the processing fee of US\$25 (twenty five US dollars) only, which is non-refundable. Please make sure that you have filled up all the necessary details in the application form.
3. Applications from all applicants will be collected and processed after the due date of submission of applications and the decision will be notified to the applicants by email and regular mail within two weeks. Owing to possible delays or loss of regular mail, it is suggested that you give an email address and/or fax number so that information can be sent to you through these means as well.
4. Applicants must confirm acceptance or declination of the Scholarship within one week of receiving the information, failing which the Scholarship will be offered to the next applicant on the waiting list. Applicants on the waiting list will be notified by email/fax only and their status will be confirmed one month before the commencement of the course.
5. On acceptance of the Scholarship/Deferral of Payment option, the registration deposit for the course has to be sent immediately and must reach KYM within one month of the commencement of the course.
6. KYM reserves the right to accept or reject applications and offer Scholarships or Deferral of Payment options. Reasons for either decision will not be shared under any circumstances.
7. Applicants for Scholarship may as an alternative, in certain cases, be offered a Deferral of Payment instead, as the panel may deem fit.
8. If KYM comes to know that the applicant has given any information which is not true, the Scholarship or Deferral of Payment option, which was granted, will be cancelled. A fine of US\$250 will also be charged for providing wrong information and the applicant will never be allowed to re-apply in the future.
9. In cases where Deferral of Payment option is provided, participants will have to pay part of the fee at the time of the course and the remaining on or before the due date mentioned in our communication. Failing this, a fine of US\$250 will be charged, which in addition to the remaining payment will have to be made within one month of the due date. The applicant will also be barred from applying for future Scholarships. *For example, if the due date was December 10, 2002, and the remaining amount due was US\$500, a sum of US\$750, will have to be paid on or before January 10, 2003.*
10. However, if there is a strong reason why the Deferred Payment was not possible within the stipulated time, the applicant will have to apply for a further Deferral, which will be allowed only once. KYM will decide the duration of this Deferral based on the individual case in question. This application has to be made at least one month before the payment is due.
11. Since KYM is a non-profit organization, which is interested in supporting eager and deserving students only, all applications must be genuine.
12. The decision as to the award of the Scholarship or Deferral of Payment will be taken by the Panel appointed by the Trustees of KYM, based on the merit and need of the applicant.
13. The decision of the Panel will be final, and the deliberations of the Panel will not be disclosed or made available for scrutiny.
